PROCEEDINGS:

- 1. Mr. S.K. Bhattacharya informed the august gathering about the sudden tragic demise of Sh. Radhey Shayam Gupta, Vice-President Action Committee, Chairman, Federation of Management of Educational Institutions. All present observed one minute silence in honour of Sh. R.S. Gupta and prayed to Almighty God to give strength to the grieved family and keep the departed soul rest in peace.
- 2. i) Mr. Bhattacharya informed that DPS, Rohini challenged CIC's order in the matter of applicability of RTI on DPS School. Hon'ble High Court has made Action Committee a party to this case. Meanwhile stay has been granted. The next date of hearing is 20th December, 2011.
 - ii) Mr. Bhattacharya further informed that the Senior Advocate Mr. Kamal Kr. Gupta, would be representing Action Committee in this case and he would be assisted by Advocate Mr. Atul Jain.
- 3. Advocate, Mr. Atul Jain, talked about the various orders and sections of RTI and discussed why it can't be made applicable to Private Unaided Schools which were not receiving any form of grant from the Govt.
- 4. Mr. Bhattacharya informed that the three member committee appointed by the High Court to look into the accounts of the schools have started functioning. If any school requires any help then they can contact Mr. S.L. Jain on telephone. Mr. Jain will provide help and guidance in proper book keeping.
- 5. Mr. M.L. Babbar reported that his committee had made and drafted suggestive guidelines for admission to Nursery Classes. The detailed guidelines would be circulated.
- 6. Mr. Bhattacharya informed that Mr. Ashok Aggarwal has filed SLP No. 4618 in the High Court whereby he is demanding infrastructure for special need children. The Action Committee was seeking legal opinion in the matter from Mr. Promod Gupta and Mr. Rakesh Khanna.

- 7. Mr. Bhattacharya informed that some officers of Directorate of Education were insisting on Utilization of Funds Certificate in Form No. GFR 19-A wherein the term "Grants-in-Aid" is used. Since the Unaided Schools are not getting any kind of "Grants-in-Aid", therefore, it would be wrong to give utilization certificate in these terms. However, legal opinion was being taken.
- 8. Mr. S.L. Jain talked about the proper account keeping. He also insisted that transparency should be observed while keeping the official records.
- 9. Mr. Bhattacharya proposed that we should have frequent General Body Meetings, atleast once in two months. Everyone agreed to it.
- 10. Mr. R.C. Jain told that he had approached Dr. Sunita S.Kaushik , Addl. D.E.(Sch)&R.D.E.(C/W) Directorate of Education and Delhi Police about non-applicability of Anti Corruption Act on Private Unaided Schools.
- 11. The meeting came to close with the vote of thanks to the chair.
